Fundraising Initiative

Since the first scholarship was awarded in the year 1643 by a former Harvard student named Lady Ann Radcliff Mowson, America has been dependent on the donor and sponsor scholarship system. For nearly 400 years students have been applying for scholarship funding based on the providers eligibility criterion. It was not until year 1950 when student-athletes begin being awarded scholarship funds from the collegiate athletic associations based on their athletic performance. It is time for America to revolutionize our scholarship system so that students will no longer have a 95.5%* chance of NOT being selected as a scholarship recipient. In order to achieve this objective we must first become educated on what a scholarship 'is' by definition.

According to **IRS Topic No. 421**: a scholarship is **non-taxable income** so long as the amount received is used for enrollment in an educational institution or for necessary supplies for a course at the educational institution. In other words, the government says that they will NOT tax our funds when we 'pool' our money together, establish a criterion on how the recipient(s) of the funds will be determined, and use the funds as scholarship funds. So what does this mean? It means that America must find a Source of Funding that may be used as scholarship funds so that we are no longer dependent on the donor and sponsor scholarship system. The solution to this problem is through the Cost of Entry in a Scholarships 4 Us® Accredited Event.

Scholarships 4 Us® was founded in 2023 by Michael Vincent Duncombe to revolutionize the after school youth sports and activities market. We must unite in the comprehensive solution to student loan debt and for the improvement in the mental health of our children. We shall fulfill this purpose by providing a scholarship system that every eligible student in America can participate in so they will have access to unlimited scholarship funding through a program that is written *4 Us-* Scholarships 4 Us®.
