

To incentivize former Student-Participants to request the disbursement of their accumulated prize funds as a scholarship award- Scholarships 4 Us® created the Scholarship Match Award.™ The award is only available to former Student-Participants and the recipients will receive a full-tuition scholarship to an accredited 4-year undergraduate program. All former student-participants are eligible to apply and reapply for a master’s degree program with the presentation of a business solution.

Individuals and organizations across the nation can show their support through tax-deductible donations with the purpose of matching the total number of students enrolled. If Scholarships 4 Us® has 7 million enrollees, then the goal is to raise \$7 million, which will be a recognized as a 100% Match. The total funds raised each year shall be known as the ‘Match Cap’ that will determine the number of full-tuition scholarships we are able to provide. Scholarships 4 Us® will partner with a scholarship provider for the management and administration of the Scholarship Match Award™. Eligibility for the award is determined by the sole discretion of Scholarships 4 Us®.

The current situation in the United States of America is that systems are either outdated, broken or undefined. We, as a nation, have the advancements in technology, an abundant of resources, brilliant minds, but are still missing comprehensive solutions for many of the fundamental systems that make our nation function. Applicants must demonstrate through our application process how they are going to use their field of study(s) to provide a solution to a system that is outdated, broken or undefined.

The Award Director is appointed by the ownership company, FanastasiaEstates™, to ensure the Scholarship Match Award™ is prudently managed and operated. The purpose of the appointee is to share the benefits of Scholarships 4 Us® in the community in order to fulfill the goal of being at a 100% Scholarship Match Cap each year.

The Award Director is responsible for the final decision in the selection-making process for the Scholarship Match Award™. Disbursement of scholarship funds are required to be awarded on an objective and non-discriminatory basis, this structure provides a system of transparency and consistency. In compliance with Federal law, The Scholarships 4 Us® Program and its Scholarships Match Award™ will not discriminate in the terms, conditions, or privileges of participation on the basis of race, color, religion, gender, national origin, age, disability, or sexual orientation.

Ineligible Students

- ✓ Planning to attend an Ivy League School or foreign educational institution (*excludes study abroad*)
- ✓ Majors in STEM (Science, Technology, Engineering or Mathematics)
- ✓ Awarded a full-tuition academic or athletic scholarship
- ✓ A spouse, child, or grandchild of any current or former affiliate of Scholarships 4 Us®, FanastaciasEstates™, or the Accounting & Bookkeeping organization associated with the business operations

Applicants shall meet the following conditions to apply

- Request the disbursement of accumulated prize funds as a scholarship award*
- U.S. Citizen or permanent resident
- Enrolled in The Scholarships 4 Us® Program for at least 3 years
- Participated in at least 25 Accredited Events
- Current high school senior** planning to attend a 4-year undergraduate degree program or an undergraduate student planning to attend a master's degree program
- Majoring in Economics, Education, Entrepreneurship, Philosophy or Political Science
- Demonstrate a financial need based on household income
- Have an accumulative minimum grade point average of 3.0 on 4.0 scale (*or its equivalent*)

*If no prize funds have been accumulated then all other conditions must be met to apply

Submission Requirements

- I. Proof of Citizenship
- II. Include a copy of the first two pages of your household’s most recently filed IRS 1040 form(s) used for the Financial Information Page. If you are being claimed as a dependent on another person’s IRS 1040 tax return, you must submit the first two pages of that particular tax return with the application. Note: Please black out any sensitive data including Social Security Numbers.
- III. Provide a current, complete, transcript of grades. Transcripts must display student name, school name, grades and credit hours for each course and term when each course was taken. Grade reports are not accepted.


Undergraduate applicants for The Scholarship Match Award™ must submit a 3-5 minute video about their life experiences, how those experiences influenced their path in life, and the reason they are choosing to study Economics, Education, Entrepreneurship, Philosophy or Political Science. The video should include an experience in which a system that is outdated, broken or undefined, has had a *major* impact in their life and provide a proposal for a potential solution. Examples of systems (*not limited*) are:

- Adoption System
- Criminal Justice System
- Education System
- Systems of Energy
- Gun Laws System
- Healthcare System
- Housing Systems
- Hiring System
- Immigration System
- Infrastructure System
- Mental Health System
- Parenting System
- Political System
- Retirement System
- Systematic Racism
- Systems for Veterans
- Travel Systems
- Voting System

The purpose of the *Solution Proposal* is for undergraduates to establish a vision and path to follow through their 4-years of study. Throughout their journey, students should be working towards developing a Business Solution that may be further achieved by enrolling into a master's degree program.

Master's degree applicants shall submit a 5-10 minute presentation that describes their business model and plan. The presentation must be recorded and include the following components of an Executive Summary:

- ◆ Company Name
- ◆ Mission Statement
- ◆ Purpose
- ◆ Goal
- ◆ Motto
- ◆ Management of Company
- ◆ Market Analysis
- ◆ Competitive Advantages
- ◆ Business Summary



The selected finalist will be invited for a virtual meeting with the Award Director and members from Scholarships 4 Us®. The purpose of the interview is to learn more about each applicant's personal story, goals, and admirations for developing a solution to a system that is outdated, broken or undefined.
